

**RENEWAL OF THE COMPUTER MATCHING AGREEMENT
BETWEEN
THE SOCIAL SECURITY ADMINISTRATION
AND
THE DEPARTMENT OF LABOR**

SSA Match #1015

Under the applicable provisions of the Privacy Act of 1974, amended by the Computer Matching and Privacy Protection Act of 1988 (5 U.S.C. § 552a), a Computer Matching Agreement (CMA) will remain in effect for a period not to exceed 18 months. *See* 5 U.S.C. § 552a(o)(2)(C).

Within three months prior to the expiration of such CMA, however, the Data Integrity Board (DIB) may, without additional review, renew the CMA for a current, ongoing matching program for a period not to exceed 12 additional months if:

1. such program will be conducted without any changes; and
2. each party to the CMA certifies to the DIB in writing that the program has been conducted in compliance with the CMA.

See 5 U.S.C. § 552a(o)(2)(D).

Only a “significant change” to an existing CMA requires a new agreement, notice, and reporting. *See* 5 U.S.C. § 552a(r) and Office of Management and Budget (OMB) Circular A-108, Sec. 8.b. No significant changes have occurred to date, and thus the following matching program meets the conditions for renewal upon signature of the certifications at the end of this renewal agreement:

Recipient Agency:	Social Security Administration (SSA)
Source Agency:	Department of Labor (DOL)

III. PURPOSE OF THE RENEWAL:

The purpose of this renewal is to extend the terms, conditions, and safeguards of Computer Matching Agreement #1015.
