#### **Application Executive Summary**

This is an FFY 2020 Section 5311(c) CARES Act application in the amount of \$12,709. Per the CARES Act, the grant requests 100% federal share. This application utilizes CARES Act funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes transit services for the Tesuque Pueblo which contracts with NCRTD for continued transit services as depicted in the District's recently adopted service plan. The Tesuque Pueblo is located in North Central New Mexico and borders the City of Santa Fe on the north. The Tesuque Pueblo is a member of the North Central Regional Transit District. These services will provide greater opportunity for tribal and community members to access employment, medical, educational, and recreational facilities within the service area of the district it costs the NCRTD approximately \$45,000 to fund this route.

In addition to the 5311(c) CARES funding the Tesuque Pueblo also was apportioned \$13,813 in FY2020 Full Year Section 5331(c) public transportation on Indian Reservation Formula apportionments which will be applied for separately.

The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company.
