1) 600-00 Other Program Costs

This scope includes:

A) the replacement of 10 vehicles, all at an 80/20 Federal share ratio (FTA amount of \$980,522/Local amount of \$179,999). Cripple Creek was recently approved for using Toll Credits due to lack of local match. The Toll Credit request is attached within this application

5) 634-00 Intercity Bus (ICB)

Five ICB route services were selected for FTA ICB funds in the federal amount of \$1,987,261/local amount of \$997,520, and Transportation Development Credits in the amount of \$494,870. Two routes utilized Greyhound In-Kind match at a 50/50 rate. The In-Kind match letters are attached within this application. Three routes were approved for Transportation Development Credits, which essentially increases the federal share to 100% of the total service cost.
