The application is for Section 5311 and Appalachian Development Public Transportation Assistance Program funds. This grant is a partial obligation of the CARES Act Apportionment, which totals a federal amount of \$65,523,351. The remainder of the Tennessee CARES apportionment will be obligated after TDOT can better assess the long-lasting impact of the COVID-19 pandemic on our communities across the state. Of the \$32,816,676 obligated in this grant, Tennessee included the full Appalachian apportionment amount of \$1,100,000.

The CARES Act emergency assistance for the 5311 Program will be allocated to Tennessee's existing 5311 Rural subrecipients for operating activities that keep public transit available and safe in all 95 counties of the state. This grant will provide funds to nine (9) rural public transportation systems for transportation in non-urban areas and two (2) rural transit-intensive agencies in East Tennessee.
