This is a FFY 2020 Section 5311 Rural Area Formula (CARES Act) application in the amount of \$14,023,652 (100% Federal Share) for Section 5311(f) Intercity Bus activities, representing 15% of the total FFY 2020 Section 5311/5340 apportionment: \$93,491,001. This project utilizes FFY 2020 Section 5311(f) Rural Area Formula (CARES Act) funding to support intercity bus service across North Carolina. Funds will be allocated to intercity bus providers to help respond to and recover from the COVID-19 pandemic within the State of North Carolina. The project is programmed to provide additional funds for intercity bus providers to meet operational needs, including but not limited to: salaries, personal protective equipment (PPE), cleaning supplies, operations salaries, administrative leave pay, and COVID-19 leave pay as authorized by the CARES Act. These funds will be used for eligible expenses (net fare revenues) incurred on or after January 20, 2020. This application is programmed to provide immediate funds for intercity bus providers.

Project Benefits

This project will benefit riders and providers of intercity bus services across North Carolina by providing funding to address lost revenues and increased expenses incurred due to COVID-19. Other benefits are the provision of salaries for staff on administration leave and continued connections for travelers between rural areas. Intercity bus service is particularly critical for travelers that do not have access to personal vehicles and where other forms of public transportation such as rail, are not available. Intercity bus transportation is an integral part in building a "seamless public transportation network" across North Carolina by providing citizens statewide access to intercity, interstate, regional, and connector services to other modes of transportation including intercity bus, commercial air, rail, and ferry services.
