Application Executive Summary

The Winnebago Tribe of Nebraska requests Federal FY2020 \$528,617 from the DOT/FTA, Public Transportation on Indian Reservations Section 5311 Program to extend the Tribe's maintenance/vehicle storage facility. The project selection IDs are D2021-TRTR-024 (\$24,472) and D2021-TRTR-025 (\$504,145).

The proposed project will include the addition of a 30' X 80' extension to the existing building. This extension will provide additional maintenance bays, indoor vehicle parking, separate restrooms for male and female employees, and a training room that can provide a safe storm shelter for employees and visitors. In order to safely facilitate access to critical services, our facility is in need of improvements and expansion. Facility improvements will increase patron safety and access and bring our facility into compliance with ADA, State, and Federal safety standards.

This application addresses the Winnebago Tribal Transit (WTT) program's objective to meet the needs of its approximately 4,000 patrons (both Tribal members and members of the general public), many of whom reside rurally and rely on WTT services to access critical employment, healthcare, and social services.

Grant funded improvements and expansion of our Tribal Transit facility will not only help us to meet the immediate needs of the Winnebago community, but will also support our program's participation in the cooperative efforts of the Winnebago Tribe and the State of Nebraska in addressing transportation needs of the broader northeast Nebraska area.

Project Description

The Winnebago Tribe of Nebraska requests \$528,617 from the Department of Transportation, Federal Transit Administration, Public Transportation on Indian Reservations Program. The tribe requested and received a waiver for the 10% match, so match documentation is not included in the grant budget.

The proposed project will include the addition of a 30' X 80' extension to the existing building. This extension will provide additional maintenance bays, indoor vehicle parking, separate restrooms for male and female employees, and a training room that can provide a safe storm shelter for employees and visitors.

The goal of this grant is to support the Winnebago Tribal Transportation program's increased ridership and operations through an expansion of the Tribal Transit Facility. We have experienced a 53% increase in ridership during the last ten years; our on-going growth of passengers has gone from 15,423 in 2009 to 29,018 to/from the Casino/Resort and 374 general public in 2019. We anticipate that this growth rate will increase as the COVID pandemic comes to an end, and this project will allow us to meet those increasing needs for transit services.

Project Benefits

The successful completion of this project will facilitate increased ridership and access to transportation services by WTT program patrons, and will also allow Tribal Transit employees to participate safely in meetings, trainings, and staff development activities with adequate space to accommodate social distancing requirements during the coronavirus pandemic.

The exact number of individuals impacted by our services is difficult to measure as we not only serve the residents of Thurston County, Nebraska, Native Americans in the Sioux City and South Sioux City area use the service to access healthcare at the Winnebago Tribe's 12 Clans Unity Hospital/Winnebago Comprehensive Healthcare Services. Both the Winnebago and Omaha Reservations make up a little more than the entirety of Thurston County, Nebraska.

The Title VI equity analysis must compare the equity impacts of various siting alternatives, and the analysis must occur before the selection of the preferred site.
- b. When evaluating locations of facilities, recipients should give attention to other facilities with similar impacts in the area to determine if any cumulative adverse impacts might result. Analysis should be done at the Census tract or block group where appropriate to ensure that proper perspective is given to localized impacts.
- c. If the recipient determines that the location of the project will result in a disparate impact on the basis of race, color, or national origin, the recipient may only locate the project in that location if there is a substantial legitimate justification for locating the project there, and where there are no alternative locations that would have a less disparate impact on the basis of race, color, or national origin. <u>Application Executive Summary:</u> The Winnebago Tribe of Nebraska requests Federal FY2020 \$528,617 from the DOT/FTA, Public Transportation on Indian Reservations Section 5311 Program to extend the Tribe's maintenance/vehicle storage facility. The project selection IDs are D2021-TRTR-024 (\$24,472) and D2021-TRTR-025 (\$504,145).

The proposed project will include the addition of a 30' X 80' extension to the existing building. This extension will provide additional maintenance bays, indoor vehicle parking, separate restrooms for male and female employees, and a training room that can provide a safe storm shelter for employees and visitors. In order to safely facilitate access to critical services, our facility is in need of improvements and expansion. Facility improvements will increase patron safety and access and bring our facility into compliance with ADA, State, and Federal safety standards.

This application addresses the Winnebago Tribal Transit (WTT) program's objective to meet the needs of its approximately 4,000 patrons (both Tribal members and members of the general public), many of whom reside rurally and rely on WTT services to access critical employment, healthcare, and social services.

Grant funded improvements and expansion of our Tribal Transit facility will not only help us to meet the immediate needs of the Winnebago community, but will also support our program's participation in the cooperative efforts of the Winnebago Tribe and the State of Nebraska in addressing transportation needs of the broader northeast Nebraska area.
