Application Executive Summary

This application is to request FY2020 Section 5311 Tribal Tribal Formula Funds apportioned to the Yavapai-Apache Nation, Arizona, in the amount of \$120,034.

Purpose: Purpose of this application is to assist with the continued operation of the Yavapai-Apache Transit System. The Yavapai-Apache Nation will use 2020 Formula Funds to continue and improve Public Transit System. The Yavapai-Apache Nation has completed the process of expanding the Public Transit System by adding additional routes and times. Funds from this application will be used in this expanded operation for maintenance, salaries and supplies, and travel. Funds will be used in upgrading employee compensation, adding additional transit operators and continued safety training and other trainings as available for all operators and support staff. Remaining funds will used to cover fuel costs, operational supplies and vehicle maintenance. This grant applies for \$120,034 in section 5311 funds for the Yavapai-Apache Nation to support costs such as driver salaries & benefits, vehicle maintenance, fuel, operating supplies, and travel to annual conferences.

Activities to be Performed: Activities that will be performed will be a review of current employee status and adjust salary & benefits as needed while adding additional operators to cover expanded services. Additional activity will be the scheduling transit vehicles for routine maintenance, scheduling training for employees and ensuring all vehicles have adequate safety, COVID-19 and passenger services supplies an board at all times.

Expected Outcomes: Outcomes expected from this application funding will be to improve Yavapai-Apache Transit by retaining and adding employees, ensure operators are properly trained and vehicles are safe to operate over the expanded rural routes.

Intended Beneficiaries: First Beneficiaries of this project will be members of the Yavapai-Apache Nation and other residents of the rural Verde Valley of Central Arizona. Yavapai-Apache Nation has successfully operated a public transit system located in the Verde Valley of Central Arizona. The system covers 3 towns a rural areas adjacent to Yavapai-Apache Nation. Yavapai-Apache Transit coordinates with other local transit systems to maximize coverage and provide best possible service to transit users. Funding will allow these services to continue!
