Application Executive Summary

This application is to request FY 2021 and FY 2022 Section 5311 funds apportioned to the Arizona Department of Transportation (ADOT) in the amount of \$6,411,237, and \$10,696,501, and \$1,000,000 in FY2021 STBG FHWA Transfer funds for a total of \$18,107,738.

Purpose:

The purpose of this award is to provide the state of Arizona and its subrecipients administrative assistance, operating assistance (including intercity), eligible capital projects, and for the rural transit assistance program (RTAP) for the state and its subrecipients.

Activities to be Performed:

Funds will be used to cover eligible operating expenses such as driver salaries, fuel, items having a useful life of less than five years, project administration and preventive maintenance, in order to continue transit operations. Funds will also be used to cover eligible capital expenses such as the purchase of one bus lift. Funds will also be used for transit planning (Five Year Transit planning and Transit Center Feasibility/Site Selection/Environmental planning), training, technical assistance, and state administration.

Expected Outcomes:

Continued safe and effective operation of transit services, and funding for planning projects for rural areas of the State of Arizona.
