Application Executive Summary

This application is to request FY 2020 Section 5311 (c)(2) Rural Area CARES Act funds apportioned to the Hualapai Tribal Council, Arizona in the amount of \$930,065. This is the transferred/allocated fund from AZDOT.

This application utilizes CARES Act funding to prevent, prepare for, and respond to coronavirus. This grant applies for \$930,065 in Section 5311 (c) (2) FTA Rural Area CARES Act for Hualapai Tribal Council, to support operating costs for the for the period of 1/1/2020 to 9/30/2023.

Purpose: This CARES Act Allocation will be used by Hualapai Transit to support Operating costs.

Activities to be performed: Funds will be used to cover all eligible operating expenses such as driver salaries, fuel, items having a useful life of less than one year, office supplies, salaries for 10 employees, 2 administrative staff, PPE to prepare for and respond to COVID-19, purchase face masks for staff and public to prevent the spread of COVID-19.

Expected Outcomes: Funding will permit Hualapai transit to continue operations that would otherwise have to be cut due to lack of funding. Maintain safe reliable transportation for the rural communities along Route 66 and the Hualapai reservation during the 2020 Covid-19 pandemic. Provide for extra cleaning and disinfectant supplies, equipment and hours need to ensure a clean, sanitized, and safe physically distanced environment for drivers and passengers.
