Application Executive Summary

PURPOSE: This is the FY21 Amendment 3 to Grant 2019-002: This amendment adds \$\$2,120,496 of Rural CMAQ Appropriation for Year FY21 state allocation to replace vehicles that have reached their useful lives.

FUNDING SUMMARY:

TOTAL PROJECT COST: \$2,650,620

FHWA transferred CMAQ funds to 5311 to fund replacement vehicles.

ACTIVITIES TO BE PERFORMED: IOWA DOT is applying for funding to purchase 27 revenue replacement vehicles to be used in the provision of public transportation service by our subrecipient agencies

EXPECTED OUTCOMES:

Service reliability, on-time performance and safety are strongly influenced by the condition of the capital assets. New reliable transit buses are essential for sustaining and increasing transit ridership. These funds will enable Iowa's transit systems to operate their vehicles reliably and keep public transportation systems in a state of good repair. This is essential to sustaining existing transportation services, providing mobility, essential services, and supporting livable communities.

SUBRECIPIENT ACTIVITIES:

Iowa DOT's subrecipients are the beneficiaries of this funding request and will procure new transit vehicles. The four small urban and regional systems include, Fort Dodge, Muscatine Region 10, Region 2.

INTENDED BENEFICIARIES: The intended beneficiaries are citizens all over the state of Iowa.

PROJECT LOCATION: The vehicles will be provide services in the City of Fort Dodge, City of Muscatine, and the counties served by Regions 10 and Region 2 (map attached in documents section).

FFY21 Local funding: comes from general fund levies and sometimes from "Trust and Agency" levies. Each transit system has certified that local shares for their projects are available.

The overall grant end date for Amendment December 31, 2027.

The Iowa Department of Transportation Commission has approved the use of these funds for vehicle replacement projects. The funds have been transferred from FHWA to FTA (attached).

Each transit system with projects contained in this application have been determined to be serving minority populations based on 2010 census data.

Local funding comes from general fund levies and sometimes from "Trust and Agency" levies. Each transit system has certified that local shares for their projects are available.

Certification and Assurances: Individual subrecipient Certifications and Assurances are a required part of the subrecipients consolidated funding application materials submitted to the Iowa DOT annually. This documentation is on file at the DOT and is available for FTA inspection at any time.

Planning/Programming: The Iowa DOT requires all transit projects be included in the State Transportation Improvement Program (STIP), approved by FTA October 1, 2020.

A copy of the October 1 Master Agreement is on file in the Department's Office of Public Transit, located at 800 Lincoln Way, Ames, IA 50010. All sub-recipients have been provided the FTA's Web Site address

so that they may obtain a copy.

Public Involvement: Iowa requires a public hearing for each transit project programmed in the STIP. The public hearing may be combined with another hearing. A public hearing notice is required to be published approximately 30 days in advance of the hearing, in a newspaper of general circulation serving the project area. The notice is also submitted to the Office of Public Transit for inclusion in the Private Sector Clearinghouse mailing. An affidavit of publication is required. Proceedings of the hearing must be included with the application. This may be a formal transcript or it may be minutes of the board meeting at which the hearing was held, etc., so long as any comments made at the hearing are recorded. The public hearing documentation is maintained in the subrecipients application files and is available for FTA inspection at any time.

No projects in this application are using force account labor for any activities in the budget.

Project Details Replacement vehicles

All vehicles described in the program of projects as replacements for existing transit rollingstock are listed in the attached table entitled: Vehicles Proposed for Replacement. They all well exceed FTA's "service life" requirement respective to that type of equipment.

Each vehicle in this application will be purchased with surveillance systems. The surveillance system would provide security for the driver and monitoring for problems that arise such as vandalism, unruly behavior and criminal activity. These surveillance systems will deter this type of behavior, along with providing useful information investigating criminal activities. No surveillance systems in this application are tied to an ITS project.

Only Transit Vehicle Manufactures (TVM) with an approved FTA DBE program and goal will be utilized for Iowa vehicle procurements.

These vehicles will meet the Clean Air Act (CAA) and American with Disabilities ACT (ADA) requirements. Passage of the Americans with Disabilities Act (ADA) affords further justification for the federal assistance sought in this grant application. This greatly assists Iowa's transit systems in meeting their ADA's goals. All vehicles in this application are ADA accessible.

All transit systems included in this grant amendment are public non-profit agencies.
