Application Executive Summary

Amendment #1 (July 2022)

This amendment deobligates a total of \$460,134 in FFY 2020 Sec 5311 formula funds. These will be reobligated in new pending application #1160-2022-10. Remaining activities in this award will be completed no later than 9/30/2022 and this award will be closed.

The total is composed of the two following amounts:

- 1) This amendment de-obligates \$10,976 from Intercity Bus Project Administration. The activities in this project are complete and finished under budget. The funds to be deobligated from this project are FY20 funds and are lapsing. These funds are available to recover and reapply for in a new award until 9/30/2022. SDDOT intends to reapply for the FY20 funds in a new award before 9/30/2022. In total, this application uses 1.2% of the FY20 apportionment for ICB projects. See Governors letter approving less than 15% to be used for ICB needs across the state.
- 2) This amendment de-obligates \$449,158 from Operating Assistance. The activity is complete, and this amendment will bring costs closer to actuals. Due to COVID relief funds operating assistance came in under budget. The funds to be deobligated from this project are FY20 funds and are lapsing. These funds are available to recover and reapply for in a new award until 9/30/2022. SDDOT intends to reapply for the FY20 funds in a new award before 9/30/2022.

Purpose of the Award: The SDDOT is deobligating a total of \$460,134 in FY20 5311 funds. These funds are from projects that came in under budget and are complete. FY20 funds that have not yet lapsed will be reprogrammed for eligible 5311 projects.

Activities to be performed: This amendment will deobligate \$460,134, with the following changes being made:

Project 1. This amendment will deobligate \$10,976 to reapply for in a new award.

Project 4: This amendment will deobligate \$449,158 to reflect actual operating costs. These funds will be used in a new award.

Expected Outcomes: This amendment will move funds into the correct categories to show actual costs. The projects remaining will allow agencies to acquire planning activities to benefit their agency and the State as a whole.
