#### **Application Executive Summary**

This application requests FY20 and 21 Section 5311 Tribal Transit Program Formula funds apportioned to the Oglala Sioux Tribe (OST) for the amount of \$1,582,121, representing 100% federal share of the total eligible amount. The funding breakdown is as follows:

\$806,232 FY20 (Lapsing and full apportionment) \$775,889 FY21 (full apportionment)

Purpose: Support the continuation of the deviated fixed route rural transit service on the Pine Ridge Indian Reservation and purchase needed support and security equipment.

Activities to be performed: Four projects are included in this grant to fund the following:

- 1. Build an outdoor shelter for passengers at transit center
- 2. Upgrade video surveillance of transit facility
- 3. Purchase skidsteer and trailer for use in garage and transit compound
- 4. Operating Costs of Oglala Sioux Transit

Expected Outcomes: Operating and equipment which will allow the provision of safe and reliable public transportation on the Pine Ridge Indian Reservation.

The Pine Ridge Indian Reservation is extremely rural, with an under-developed economy and infrastructure. According to the U.S. Bureau of Indian Affairs, unemployment on the Reservation is 89 percent. (BIA Labor Force Report, 2005). Persons below poverty levels on the Reservation remain among the highest in the United States with the 2009 Census data indicating 51% for Shannon County, 37.8% for Bennett County and 36.1% for Jackson County.

The Transit Program provides transportation in handicapped accessible vehicles (buses and vans) as a deviated fixed route transit system. In order to serve the widely dispersed communities on the Reservation, the Project has established routes with bus stops convenient to the local residents that provide this access for transportation to wherever their destination is. Transit services began on February 3, 2009 with a deviated fixed route system covering approximately 1,806 miles daily along five routes with

the main route being 111 miles one way - from the village of Wanblee on the eastern side of the Reservation to Prairie Wind Casino on the western side.

Unlike urban areas, the Pine Ridge Reservation's communities are widely separated and located along rural roads that were not designed for efficient transportation. The current seven (7) routes travel through eighteen (18) of the main villages on the reservation with 115 stops providing the general public with access to college courses, employment, entertainment, medical, business and shopping services on the reservation.
