### **Application Executive Summary**

Kaw Nation (UZA 400000) is applying for FY2021 Sec 5311 Discretionary funds (D2022-RPTC-013) in the amount of \$416,604 for operating. This is an FFY 2021 Section 5311c ARP funding application representing 100% federal share of the total eligible amount. This application utilizes ARP funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes operating assistance.

The Kaw Nation, a federally recognized tribe located in northern Oklahoma, proposes to implement transit service within its service area to meet employment, health care, education, and livability needs. The Kaw Nation service area is rural with known transportation deficiencies. The Kaw Nation intends to create a fully staffed transit department and to operate and maintain a transit fleet that serves its tribal members and the rural communities within the KNSA. Fixed-routes and on-demand services will be provided for the Kaw Nation population centers: Braman, Kaw City, Newkirk, and Ponca City. The transit system will meet the transit needs of the rural area and improve the quality of life of tribal members and the local communities. This application utilizes ARP funding to help respond and recover from the COVID-19 pandemic. 100% Federal Share. No STIP required.

# **Award Description**

#### **Purpose**

The Kaw Nation currently has no transit system. Limited transit is available for the multi-county area of northern Oklahoma and from Ponca City, but a gap exists for the Kaw Nation tribal members who live within the rural communities. A transit system would enable the Kaw Nation to meet transportation needs for access to jobs or health care, special needs of elders or individuals with disabilities, behavioral health care needs of youth, income-based community needs, and other mobility needs.

The proposed project is a capital investment to establish a transit system within the Kaw Nation service area. This transit system requires the creation of a fully staffed transit department, including offices and supplies, a schedule coordinator and vehicle operators, training, and vehicle operations and maintenance.

### Activities to be performed:

Upon receipt of the funds, the Kaw Nation intends to proceed with the office set-up, purchase of vehicles, and the hiring and training of a transit coordinator and drivers. The coordinator would collaborate with the Administration, Council, and Transportation Department to advertise the transit service, to track ridership, and ensure training and safety. The coordinator will oversee the drivers of the transit vehicles, dispatch calls, and coordinate with Drivers. The transit service will provide greater access to healthcare, employment opportunities, education centers, and other recreation and cultural facilities.

### **Project Description**

The Kaw Nation (KN) is a federally recognized, self-governing tribe headquartered in Kaw City, Oklahoma. The People of the Southwind, known as the Kaw Nation, was formally established under the Oklahoma Indian Welfare Act of 1936. The constitution of the Kaw Nation was ratified on April 20, 2011 and amended April 29, 2016. The Tribal Council is the sovereign legislative body of the Kaw Nation. Council members are elected and fill the officer positions of Chair, Vice-Chair, Secretary, and four Council Members. The current Chair is Lynn Williams. The General Council consists of all citizens of the Kaw Nation, 18 years or older who are deemed mentally competent. A quorum of the General Council is comprised of 25 citizens and is required to meet quarterly.

Tribal administration buildings and services, as well as the Title VI building, the Kaw Nation Museum, Social Services Building, the Environmental Department, and the Education and Learning Center, are centralized in Kaw City. Another tribal headquarters is found in the town of Newkirk, about 12 miles northwest of Kaw City. Here, the Kaw Nation administers the Kanza Health Clinic, the Wellness Center, the Childcare Center, the Multi-Purpose Tribal Youth Building and Gym, and the White Plume Housing Addition.

The Kaw Oklahoma Tribal Statistical Area (OTSA) and the Kaw-Ponce joint-use OTSA extend over most of Kay County in northern Oklahoma and delineates the Kaw Nation service area (KNSA). Tribal members live throughout the Service Area, and the transit system intends to serve the rural communities of Braman, Newkirk, Kaw City, and Ponca City. Ponca City is the largest municipality in the county. The Kaw Nation has a mission to provide for the social, physical, and economic health of its tribal members. Kay County has a poverty rate and unemployment rate that exceeds that of the State of Oklahoma. The county population is 44,402, and over half of the residents live in Ponca City. Poverty rates are high in Ponca City, Braman, and Newkirk. In Braman and Kaw City, over a quarter of the residents are 65 or older.

The Kaw Nation currently has no transit system. Limited transit is available for the multi-county area of northern Oklahoma and from Ponca City, but a gap exists for the Kaw Nation tribal members who live within the rural communities. A transit system would enable the Kaw Nation to meet transportation needs for access to jobs or health care, special needs of elders or individuals with disabilities, behavioral health care needs of youth, income-based community needs, and other mobility needs.

### **Project Benefits**

The goals of the proposed transit system are to help elders and tribal citizens have better access to transportation for medical appointments, groceries, prescriptions, and other necessary appointments and to assist tribal members and tribal employees with better transportation to and from work and make childcare easier. The proposed Kaw Nation transit system has the potential to improve the quality of life and raise the economic stability of the service area. The transit system would allow for more residents to access employment opportunities within the county, to assist families with childcare and educational opportunities, and to provide for the welfare of the elderly.

Understanding that the transit system must serve a rural area and small towns, the routes have been

selected to provide access to the major tribal employers: the Southwind Casinos in Newkirk and Braman. Routes to, from, and within Ponca City are not only to provide access to jobs but to also ease childcare needs for tribal members. In addition to addressing socioeconomic needs, a transit system will assist the Kaw Nation in its commitment to preserve its culture and heritage by caring for elders and educating tribal youth.

On-demand services are expected to be used by elders for medical appointments. Set routes will allow regular access to the Elder Centers and Title VI resources. The transit service will encourage intergenerational interactions and the Kaw Nation will be able to share with the wider, rural community. Tribal youth will have greater access to the educational and recreational centers found in Kaw City, Newkirk, and Ponca City.

The transit service will be available 5 days a week, 7:30 am to 4:30 pm, and the Kaw Nation will begin by providing both on-demand and set routes services. The Program Coordinator will work with the Administration, Council, Elder Program, and Transportation Department to promote and advertise transit services. Starting small, the Kaw Nation will be able to maximize efficiency by adapting its transit offerings based on response and ridership. Administration has already stated that the transit services would try to cater to shift changes at the casinos.

The Kaw Nation transit system will make the rural area more livable for families and elders. The Kaw Nation views the transit program as a modern way to fulfill its cultural responsibilities. The Kaw Nation is committed to caring for its elders and guiding its youth by giving them healthy, stable childhoods that transform them into healthy, contributing adults.

#### **Additional Information**

None provided.

#### **Location Description**

A fully developed transit plan was produced in 2009 that identified the need for transit services. The plan detailed the steps and costs to implement a public transit program within the KNSA. Over the last year, the KN has evaluated its transit needs and its role to provide transit services for tribal members and the rural communities. In 2017, the Grants and Contracts Department sent out a tribal-wide survey to assess needs and wants of tribal members. Transportation for elders, health care, and education opportunities were listed. The Kaw Nation's Long-Range Transportation Plan 2020 identified better transit services as a need for tribal members.

Per request of the Chairman of the Kaw Nation, a Tribal Transit program was initiated. An itemized budget was prepared to launch the KN tribal transit department over the next three years. This grant application seeks the funding to make this program a reality. The KN invested time and effort to outline what would be required to start a transit program. This program description details the steps and itemizes the costs to implement and sustain a transit department. The KN has also prepared a 3-year budget to support the program. Routes have been delineated and the KN can start the transit service within a matter of months. The transit program can begin running routes as soon as vehicles are purchased and drivers trained.

While an existing transit program serves a wider area that includes Kay County, the transit available for the Kaw Nation tribal communities are limited. Based on the results of recent surveys and an examination of the demographics, transit services are needed and would be used by tribal members and residents of the rural communities. Within the Kaw Nation OTSA, the labor force participation rate was 54.8%, considerably lower than the state and national levels. The unemployment rate was 5.5%, higher than the state and national levels.

Administrative offices, food services, and the cultural center are located in Kaw City. The Kanza Health Clinic, Wellness Center, Housing Authority, and Southwind Casino are found in Newkirk. Braman is home to the Southwind Casino and Kanza Travel Plaza, both places of employment for tribal members. Frequent travel occurs between these population centers and to Ponca City, the largest population center. Trips include travel for work at Kaw Nation enterprises, childcare for tribal members and employees, and to tribal services offices. The proposed transit program will meet the transit need for its service area.

Cherokee Strip Transit is an on-demand system that serves Ponca City in addition to other towns throughout northern Oklahoma. Cimarron Transit provides on-demand services for Ponca City and has recently launched an app to request rides. The transit services within Kay County primarily cater to Blackwell and Ponca City. White Eagle Transit is run by the Ponca Tribe to serve its tribal members and the local community. White Eagle Transit is an on-demand service and will travel to Newkirk and Kaw City for a fee.

The KN seeks to provide transit within and between the communities, having set routes in addition to ondemand. Within Ponca City, the Kaw Nation has designed a set-route that stops at Kaw Nation sites and covers the entire town. The proposed transit system would provide reliable, set-routes services, Monday through Friday, 7:30 am to 4:30 pm, with an option for evening routes based on shift needs in Braman.

The Kaw Nation has a facility and space to accommodate for a tribal transit department. The Kaw Nation Transit Department will be housed in the Kaw Nation Medical Annex office. The facility has the office space to house the Transit Department personnel and to provide protected parking for the vehicles. Since no ground-disturbing activities would be taking place, NEPA is not applicable.
