#### **Application Executive Summary**

Arkansas DOT (ARDOT) is applying for FFY 2022 5311 Funds (RTAP (\$294,340) and rural (\$17,562,658) Federal funding for a total federal amount of \$17,856,998. This award will help to enhance and sustain reliable transit services, reduce unscheduled repairs, and improve system efficiency and reliability.

Approximately \$786,580 will be used for pre-award intercity expenses on ALI 30.09.00.

All projects are currently listed in category B until agreements and certifications are signed.

The projects selected for inclusion in this award application were derived from a fair and equitable distribution, through maximum feasible coordination with other transportation services provided by other federal sources, and consistent with the State Management Plan for the Section 5311 Program.
