### **Application Executive Summary**

This application is to request a total of Section 5311c Tribal Transit Formula funds apportioned to the Fond du Lac Band of Lake Superior Chippewa in the amount of \$851,808. This includes the following apportionments:

- \$394,245 of FY21 5311c Tribal Formula funds \*THESE FUNDS ARE LAPSING\*
- \$457,563 of FY22 5311c Tribal formula funds

These funds will be used towards the interior renovation of an existing transit garage, bus wash, and administration office. All renovations will be interior to existing structures. No new construction will be part of this grant. These funds are 100% Federal share, and no local match is required through program 5311(c)(1)(B). No STIP is required. Pre-award authority will be used to install new water pipes in an amount around \$100,000 depending on the timing of grant execution.
