#### **Application Executive Summary**

This is an FFY 2021 Section 5311 ARP funding application Pueblo De San Ildefonso in the amount of \$9,877, representing 100% federal share of the total eligible amount. This application utilizes ARP funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes expenses related to operations of public transportation including salaries and wages, preventive maintenance and repairs, fuel etc.

The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company.

Pre-award authority expenses in the approximate amount of \$21,500 were incurred from 01/20/2020 to 06/30/2020. Pre-award authority is being used for operating expenses incurred prior to grant award.

The projects in this application will not lead to a functional, location, or capacity change.

The Pueblo de San Ildefonso, or Po-Woh-Geh-Owingeh, is located north of Santa Fe and east of Los Alamos in New Mexico. Public transportation in Pueblo de San Ildefonso consists of two deviated fixed routes run by North Central Regional Transit District (NCRTD). NCRTD route 230 San Ildefonso provides local service within the Pueblo de San Ildefonso and neighboring communities of El Rancho, Jaconita and the Pueblo of Pojoaque, running seven trips a day between 6:45AM and 6:20PM on weekdays. NCRTD route 400 Los Alamos provides regional service between Los Alamos, Espaola and the Pueblo of Pojoaque via two trips a day on weekdays.

The Pueblo de San Ildefonso is a member of the NCRTD, a regional transit district that provides local and regional bus service to a population of over 290,000 people across a 10,000 square mile service area. NCRTD currently operates a network of three fixed routes, 23 deviated fixed routes, paratransit services, two demand-response services, and one dial-a-ride service. All routes are fare-free except for two premium deviated fixed routes, and all routes operate on weekdays only except for four deviated fixed routes. NCRTD service connects to other transit systems including Los Alamos Atomic City Transit, NM Rail Runner, NMDOT Park & Ride, Po' Pay Messenger Service, Red River Miner's Transit and Santa Fe Trails.

NCRTD is governed by a Board of Directors consisting of one publicly appointed representative from each of the 17 NCRTD member counties, cities, towns, villages and pueblos: the Counties of Los Alamos, Rio Arriba, Santa Fe and Taos; the Cities of Espaola and Santa Fe; the Towns of Edgewood and Taos; the Villages of Chama, Questa and Taos Ski Valley; and the Pueblos of Ohkay Owingeh, Santa Clara, San Ildefonso, Pojoaque, Tesuque and Namb.

Pueblo de San Ildefonso will contract with NCRTD to continue transit services as depicted in the District's recently adopted service plan. The Pueblo de San Ildefonso is located in North Central New Mexico and borders the City of Santa Fe on the north. The Pueblo de San Ildefonso is a member of the North Central Regional Transit District. These services will provide greater opportunity for tribal and community

members to access employment, medical, educational, and recreational facilities within the service area of the district. The NCRTD spends approximately \$35,000 a year to operate the San Ildelfonso Tribal Route. The reminder funds come from gross receipts taxes received from 4 different counties including Santa Fe County.
