Application Executive Summary

This is an FFY 2021 Section 5311 ARP funding application Pueblo of Pojoaque in the amount of \$1,195, representing 100% federal share of the total eligible amount. This application utilizes ARP funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes expenses related to operations of public transportation including salaries and wages, preventive maintenance and repairs, fuel etc.

The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company.

Pre-award authority expenses in the approximate amount of \$12,020 were incurred from 01/20/2020 to 06/30/2020. Pre-award authority is being used for operating expenses incurred prior to grant award.

The projects in this application will not lead to a functional, location, or capacity change.

The Pueblo of Pojoaque is served by eight bus routes: North Central Regional Transit District (NCRTD) deviated fixed routes 160 Santa Clara, 200 Santa Fe, 220 Tesuque, 230 San Ildefonso and 400 Los Alamos; the NCRTD 210 Pojoaque/Namb Micro Transit service; and New Mexico Department of Transportation (NMDOT) Park & Ride fixed routes Red and Blue.

Two of the routes (the NCRTD 230 San Ildefonso deviated fixed route and the NCRTD 210 Pojoaque/Namb Micro Transit service) provide local service within the Pueblo of Pojoaque and neighboring communities. The other six routes provide regional service, connecting the Pueblo of Pojoaque with north central New Mexico via direct service or connections with other NCRTD routes and other transit systems including Los Alamos Atomic City Transit, NM Rail Runner, NMDOT Park & Ride, Po' Pay Messenger Service, Red River Miner's Transit and Santa Fe Trails. All six regional routes serving the Pueblo of Pojoaque stop at the Cities of Gold Park & Ride in the Pueblo of Pojoaque, making the Cities of Gold Park & Ride a key transit center and transfer point in the region.

The Pueblo of Pojoaque is a member of the NCRTD, a regional transit district that provides local and regional bus service to a population of over 290,000 people across a 10,000 square mile service area. NCRTD currently operates a network of three fixed routes, 23 deviated fixed routes, paratransit services, micro transit service. Most routes/services are fare-free except for two micro transit zones in Espanola and Taos, the Nambe Pueblo micro transit is free in their zone, and all routes operate on weekdays only except for four deviated fixed routes. NCRTD service connects to other transit systems including Los Alamos Atomic City Transit, NM Rail Runner, NMDOT Park & Ride, Po' Pay Messenger Service, Red River Miner's Transit and Santa Fe Trails.

NCRTD is governed by a Board of Directors consisting of one publicly appointed representative from each of the 17 NCRTD member counties, cities, towns, villages and pueblos: the counties of Los Alamos, Rio Arriba, Santa Fe and Taos; the cities of Espaola and Santa Fe; the towns of Edgewood and Taos; the Villages of Chama, Questa and Taos Ski Valley; and the Pueblos of Ohkay Owingeh, Santa Clara, San Ildefonso, Pojoaque, Tesuque and Namb. As a governing member of the NCRTD, in a geographically central location, and lacking an independent local transit agency, the Pueblo of Pojoaque has significant

interest in and authority to maintain and improve local and regional transit service.
