Wyoming DOT is applying for FFY2022 5311 Statewide funds in the amount of \$9,057,339 full apportionment and FFY2022 RTAP funds of \$120,347 full apportionment. Total applied for \$9,177,686. The funds will be used for public transportation providers in Wyoming for operating, project administration, preventive maintenance, intercity bus and RTAP funding for training and technical support. The 10% allowed for State Administration will be utilized by WYDOT to administer the program. The 15% Intercity bus requirement will be met.

#### **Project Description**

To provide operating, project administration and preventive maintenance assistance for public transit service in Wyoming's rural communities. State Administration funding will be utilized by the WYDOT Transit Staff to administer the program. Intercity Bus funding provides a vital link between otherwise isolated rural areas, municipalities and the rest of the state as well as to the regional urban areas. RTAP funding provides assistance for training and technical assistance for rural transit programs.

The period of performance for all activities is October 1, 2022 through March 1, 2026.

The grant uses various matching ratios for the following activities:

Operating funds will use the sliding scale match ratio - 56.56% Federal and 43.44% Local (as per approved FHWA agreement attached).

Project Administration and Preventive Maintenance funds are matched at an 80% Federal and 20% Local match ratio.

RTAP funds are funded at 100% Federal.

State Administration funds are funded at 100% Federal. The amount does not exceed the allowable 10% amount of the apportionment.

These 5311 funds are essential for transit agencies in rural communities to provide transportation service on a daily basis during the recovery of the Covid-19 pandemic.
