Project Description

The Formulary Funding will be used on operating and administrative expendiutures that inculde but not limited to, salaries, benefits, fuel, oil, vehicle maintenance/insurance and supplies.

Project Benefits

The formula funding of \$163,823 will help the Mescalero Apache Tribe subsidize the public transportation service being provided by the local transportation provider, Zia Therapy Center (Ztrans) in Otero County, New Mexico. This funding will reduce what the tribe pays through the (638) roads fund that subsidizes public transportation for the MAT.

Additional Information

With public transportation tribal members can access transporation from Ztrans to other systems statewide, which creates a seamless system. For tribal members who cannot drive, or because of income limitations cannot afford to drive, public transportation gives them the opportunity to utilize an affordable, safe and reliable mode.

The Mescalero Apache is located in a mountainous area within Otero and Lincoln counties. The Reservation emcompasses 719 square miles, with approximately 463,000 acres. According to the US Census the population is approximately 4,005, the Mescalero Apache Tribe has a large population of

military personnel who served in Vietnam war. The economy of Mescalero, NM employs approximately 470 people, the industries include, Accommodation & Food Services, Care & Social Assistance, Arts and Entertainment and Education services. The median household income is \$31,164. The proverty rate is 31%.

Location Description

The (MAT) Mescalero Apache Tribe is located in South Central New Mexico. We are a federally recoginzed Tribe, known as the "Mescalero Apache Tribe of the Mescalero Apache Reservation". The 714 square miles of the reservation is almost entirely in Otero County but also has an unpopulated section in Lincoln County. The reservation lies on the Eastern flank of the Sacramento Mountains and boarders the Lincoln National Forest. A major highway (US70) runs through the reservation.
