The Pueblo of Zuni A:Shiwi Transit is applying for available 5311c Tribal Transportation Program FFY2021 American Rescue Plan Act for the sum of \$185,921.00. Per the American Rescue Plan Act, the grantee requests a 100% (up to 100%) federal share. These formula funds will assist with the continued prevention and operation of our public transportation program in response to the Coronavirus pandemic.

The application scope of work includes expenses for the operation of our public transportation program, the purchase of personal protective equipment, increasing workforce, employee awareness training, and retrofitting of our fleet vehicles and staff facilities to comply with CDC regulations. The Pueblo of Zuni will continue to provide transportation service for the community members of Zuni, NM, and surrounding rural areas so they may have access to essential services such as health care appointments, essential shopping, public service, and employment during the COVID-19 Pandemic.

The recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T.
