AMENDMENT #1 (6/2023):

This amendment adds the full FY23 Apportionment funding received through the Section 5311 (c) Public Transportation on Indian Reservations program funds to the application. This new project is for operating assistance for transit service through Calendar Year 2023 and into Calendar Year 2024, using FY 2023 5311(c) Formula Funds in the amount of \$76,254 (Table 10 attached).
