The Morongo Tribe established the Morongo Dial-A-Ride program in 2014 in response to the need for transit services that were absent on the Reservation. With funds from the FY 2012 Public Transportation on Indian Reservation Roads Program; Tribal Transit Grant, the Tribe was able to purchase a bus and obtain the special permitting required by the California Highway Patrol (CHP). After vehicle delivery and necessary inspections, the Morongo Dial-a-Ride program was launched in March 2014. The program has been featured in Metro Magazine and the Press-Enterprise, the local newspaper for Riverside County, California. The FY2021 Funds will be used for operating support for the program including salaries (\$15, 560) and benefits (\$5,186.) Funds will be expended by June 30, 2024.

Project Benefits

Provide transportation options for Morongo Tribal members, descendants, and employees to be able to access work and medical appointments throughout the San Gorgonio Pass area which includes Banning, Beaumont, Cabazon, and the Morongo Reservation.
