### **Application Executive Summary**

AMENDMENT #1 (06/01/23): Disregard the official amendment remark, as the dollar amount listed is incorrect. This amendment requests adding FY2021 5311c tribal transit formula funds in the amount of \$92,440 to be used for operating assistance. These funds are 100% federal with no local match required. No STIP required.

ORIGINAL: This grant includes funds from FY19 and FY20 of the 5311c program in the amounts of \$186, 304 and \$127,209, respectively. Total federal funding is \$313,513. No local match is required.

This application includes operating assistance for our Public Transit System. Time period of operating assistance is January 1, 2021 to September 30, 2023.

Presently we are operating 2 buses and 3 vans in regular service on the Red Lake Indian Reservation.
