Application Executive Summary

This application requests FFY21 and FFY22 Section 5311 Rural Area Formula funds in the amount of \$ 13,928,975. Funding amounts by sources as follows: - \$11,186,091 - Remaining funds of FFY21 Section 5311 apportionment (after allocation of \$557,542 to MT-2022-022 and suballocation of \$60,000 to the Chippewa Cree Tribe) - \$2,742,884 - Partial funds from FFY22 Section 5311 apportionment, leaving \$11, 652,264 for future use (after suballocation of \$60,000 to the Chippewa Cree Tribe). This grant will fund operating, preventive maintenance, project administration and state administrative activities for the State of Montana Department of Transportation and 40 subrecipients. 5311 Program Requirements: - FFY21 Apportionment --- Minimum 15% for ICB - This application uses \$1,259,197 (10.67%) for ICB activities to fulfill the minimum \$1,770,545 (15.00%) of the FFY21 apportionment. \$511,348 (4.33%) was allocated to ICB activities in MT-2022-022. --- Maximum 10% for State Admin - \$1,180,363 (10.00%) of the FFY21 apportionment is used on State Admin in this application.
