Application Executive Summary

This grant is for Federal Fiscal Year 2021 (FFY21). The Federal allocation for FFY21 is a total of \$18,577, 451 for Section 5311 and \$297,530 for Section 5311(b)(3), known as RTAP. Therefore, the total apportionment is \$18,874,981 for FFY21.

The Federal allocation breakdown:

FFY21: Operating Assistance \$14,292,881; Intercity Bus \$2,786,618; Program Administration \$984,605; Communications Capital Acquisition \$321,347; Capital Mobility Management \$192,000; and, Rural Transportation Assistance Program (RTAP) \$297,530. FDOT has applied for the full allocation \$18,874, 981.

The operating assistance allows separate governmental and not-for-profit entities to operate/contract public transportation service in non-urbanized areas. All of these eligible recipients are using their Section 5311 allocations to offset operational expenses of public transportation service.

The grant is for the following: capital mobility management for a cost of \$192,000 in FTA funds (Scope/ALI Code 117-00;11.7L.00); communication capital equipment for a cost of \$321,347 in FTA funds (Scope/ALI Code 116-00;11.62.02); state administration for a cost of \$984,605 in FTA funds (Scope/ALI Code 610-00;11.80.00); operating assistance in the amount of \$14,292,881 in FTA funds (Scope/ALI Code 600-00;30.09.01); operating assistance for intercity bus for a total cost of \$2,786,618 in FTA funds (Scope/ALI Code 634-00;30.09.01); RTAP training for a cost of \$45,000 in FTA funds (Scope/ALI Code 635-00;43.50.01); RTAP technical assistance for a cost of \$150,000 in FTA funds (Scope/ALI Code 635-00;43.50.02); and RTAP related support services for a cost of \$102,530 in FTA funds (Scope/ALI Code 635-00;43.50.04).

The State Administration amount of \$984,605 equals 5.3% of the Section 5311 allocation. The Section 5311(b)(3) allocation is \$297,530.

subrecipient will sign a Joint Participation Agreement with the Florida Department of Transportation. This agreement will ensure that all Federal grant requirements are met by the subrecipient.
