Kansas RTAP will offer at least 40 bus driver training events in the contract period (in addition to classes taught by Approved Trainers (ATs)) and continue to work with CTDs to plan and advertise training events. The standardized RTAP driver training program offered throughout the year includes defensive driving, emergency procedures, and passenger assistance, and advanced classes in mobility device securement and emergency evacuation. The KUTC Learning Management System provides a streamlined approach to posting, registering, and paying for trainings that are hosted by Kansas RTAP and the approved trainers. See Attachment 1 for training provided and planned by RTAP's lead trainer in FY 24.

In addition, Kansas RTAP will identify methods for providing CPR/First Aid Training to transit staff who do not get this through their agency.

Subtask 1.2. Coordinate the Kansas RTAP Approved Trainer Program

In 2019 KDOT adopted revised policies for its Approved Trainer Program to improve the quality and consistency of the training delivered statewide and require entry of training data into a portal developed and maintained by Kansas RTAP. Kansas RTAP will implement a new policy starting in FY 2024 that includes a new certification for all trainers and enhanced requirements. An Approve Trainer Workshop will be held in August 2023.

RTAP will report to KDOT twice per year (at mid-year and beginning of fiscal year) on when and where the Approved Trainers are providing training, which courses they are teaching, and who they are training.

Subtask 1.3. Provide Training for Transit Managers and Leadership Staff

In FY 2024, Kansas RTAP will develop on-demand videos that coordinate with the Kansas Transit Manager's Handbook. These videos will be developed once KDOT has completed the Kansas Public Transportation Policy Manual and will be consistent with the update to the Kansas Transit Manager's Handbook. In addition, we will host quarterly transit manager roundtable calls so that managers can learn from their peers.

Subtask 1.4. Prepare Training presentations for use at CTD Meetings.

In previous fiscal years, Kansas RTAP provided short presentations for use at CTD meetings. Kansas RTAP will continue creating these presentations in FY 2024, with voiceover narration, based on suggestions from the Kansas RTAP Advisory Board.

Subtask 1.5. Provide Webinars on Transit Topics During the Grant Period.

Kansas RTAP began presenting regular webinars in FY 18. In FY 24, we will continue these webinars on topics related to operations, management, marketing, and mobility management.
