Application Executive Summary

West Virginia Department of Transportation, Division of Public Transit (WVDOT) is applying for FFY 2021 Section 5311 Nonurbanized Area Formula Program funds, Section 5311(b)(3) Rural Transit Assistance Program (RTAP) and Appalachian Development Public Transportation Assistance Program funds apportioned to the State of West Virginia in the amount of \$11,118,143 to support the state's Section 5311 Program of Projects (POP).

The projects include operating assistance for ten (10) Rural Operators (\$6,779,445 5311 - Rural - Unrestricted formula Federal funds and \$1,892,000 Appalachian Development Public Transportation Assistance Program ADPTA) funds and two Intercity Bus Operators (\$1,355,889 Rural - Intercity Federal); training and technical assistance services (\$186,883 Federal) funded under the Rural Transit Assistance Program (RTAP); and, state administration (\$903,926 Rural - State Federal).
