#### **Application Executive Summary**

AMENDMENT #1, PROJECT 2 - AUGUST 2023 - A RAST

The purpose of this amendment is to provide GDOT's Section 5311 subrecipients with funding for capital projects.

Activities to be performed: Purchase of revenue vehicles and support vehicles for the state of Georgia's Section 5311 subrecipients to provide public transit services across the state.

Expected Outcomes: The continued safe operation of transit services for rural areas in the State of Georgia.

Intended Beneficiaries: Transit agencies and transit riders in rural Georgia.

Subrecipient Activities: Purchase of vehicle capital for rural subrecipients.

GDOT requests the use of unspent FFY2021 ARP 5311 Operating dollars to fund GDOT's SFY2022 vehicle capital purchases as detailed in the vehicle list and revised program of projects included in the application documents. This request will involve the addition of two new line items in this grant, and will result in a zero dollar balance in Operating funds. This request does not involve the use of 5311(f) Intercity Bus Operating dollars.

ORIGINAL APPLICATION

This application is to request, as the designated recipient, ARP funding for the Georgia Department of

Transportation (GDOT) Section 5311(f) Intercity Bus ARP, 5311 RTAP ARP, 5311 ARP, and Section 5307 ARP funds apportioned to the Small UZAs in Georgia. Purpose: This grant will enable GDOT to provide additional 5311 operating assistance for rural public transit systems which provide transportation services to 114 counties in the State of Georgia. As required by the American Rescue Plan Act, funds will be awarded to eligible recipients or eligible sub-recipients of Urbanized Area Formula funds or Rural Area Formula funds that, as a result of the Coronavirus disease 2019 (COVID19), require additional assistance.

The 5307 UZAs for which GDOT is applying within this project are Albany, Athens, Cartersville, Gainesville, Hinesville, Macon, Rome, and Valdosta.
