### **Project Description**

The Sisseton-Wahpeton Oyate Tribe will use TTP funds to replace one transit vehicle that has met its useful life and overhaul the engine for another vehicle. The federal share is 100% and both activities qualify for a Categorical Exclusion C-list type 7.

### **Project Benefits**

The replacement of buses will help the tribe to maintain mobility for a number of residents and fill an enormous gap in services, as it is currently the sole source of public transportation on the reservation. The purchase of this replacement bus will allow the Tribe to maintain access to destinations and services, including maintenance of all current transit service contracts with human services, employment services, educational systems, and government entities. It ensures residents have critical access to healthcare, employment, educational and training opportunities that expand ladders of opportunity. Additionally, as seen by the ridership numbers provided, the transit program is utilized by a significant number of elderly and disabled adults as well as children, ensuring not just access to services and goods, but also increased safety for vulnerable populations.

The Lake Traverse Reservation covers a vast rural area. The Lake Traverse Reservation is an impoverished rural area, with 21.3 percent of all individuals living below poverty level, so access to reliable, safe transportation is critical to individuals and families living in the area. According to 2012-2016 American Community Survey 5-Year Estimates, the unemployment rate of the Reservation was 8 percent, double that of the United States. Due to these high levels of poverty and unemployment, very few individuals have private cars, limiting their access to essential services and goods. The transit system is utilized frequently and by a vast number of reservation residents, increasing transportation efficiency and safety and improving mobility.

The Sisseton-Wahpeton Oyate Tribe will pay for the replacement of a vehicle engine for a Model 2018 Ford Transit Mobility Tran. The vehicle currently has 129,244 miles. The cost to replace the vehicle engine was \$10790, completed July 2023. SWO has an existing contract with Community Transit for the operation and maintenance of transit and vehicles.

The new engine will extend the useful life of the vehicle another 4 to 5 years per industry standard (original useful life of the vehicle is 4 years/100,000 miles).

The federal share is 100%.
