### **Application Executive Summary**

This application is to request Section 5311 funds apportioned to the State of Vermont in the amount of \$6,295,893 (Federal), \$279,783 (State), \$2,339,164 (Local).

**Purpose**

Purpose of the Award:

The Vermont Agency of Transportation is requesting approval to cover operating expenses for Vermont's 5311 qualified subrecipients including Vermont's Intercity transportation providers. VTrans is also requesting assistance for eligible capital projects, project administration expenses, third party D&A testing and for the Rural Transit Assistance Program (RTAP).

**Activities to be performed:**

Activities to be performed:

-Operating assistance: \$502,730 Federal/\$21,315 State/\$481,415 Local for Green Mountain Community Network, Marble Valley Regional Transit District, Rural Community Transportation, Southeast Vermont and Green Mountain Transit Rural.

-RTAP: \$70,232 Federal \$0 State/ \$0 Local is requested for the Rural Transit Assistance Program that is associated with carrying out FTA funded programs and training costs such as Route Match User Conference, CTAA online CTPA certification, and recurring HIPPA training. RTAP funding will be provided to AT, GMCN, GMT Rural, MRVTD, RCT, SEVT, VPTA, and TVT that will foster the development of state and local capacity for addressing the training and technical assistance needs of the rural transportation community.

**Expected outcomes:**

Expected Outcomes:

These funds will allow continued support for all existing transit projects in the rural areas in the state. All except the urban sections of Chittenden County (small urban) are considered rural. The state of Vermont is very rural and this set of federal funding will allow transit to operate uninterrupted service and continue serve large populations of Vermont in non urban areas. Additionally the capital equipment will only strengthen the ability of these rural providers to operate at fully capacity rather than dealing with maintenance issues at their facilities and failing equipment which hinders operations.

**Intended beneficiaries:**

Intended Beneficiaries:

These services are comprised of fixed route, demand response by bus and volunteers, and ADA paratransit. Rural Transit Providers deliver over half of the rides (in a total of 5,000,000) in Vermont, an admirable accomplishment given the low-density nature of the state's rural areas. The public in these rural areas will be connected to major employment sectors in the State such as Burlington and Montpelier which also have major hospitals and education centers. Vermont pays particular attention to basic mobility for all often focusing on the elderly, low income, disabled and those seeking to improve their housing and financial sustainability.

This application for Section 5311 funds is for the Vermont Agency of Transportation, the designated recipient.
