#### **Application Executive Summary**

#### AMENDMENT 1:

The Illinois Department of Transportation (IDOT) is decreasing FFY2020 Coronavirus AID, Relief and Economic Security (CARES) Act Section 5311 operating funding in Scope 300-000 (ALI 30.09.08) by \$1, 366,977 and adding it to various capital projects under scope 600-00 in Project 3 of this grant application.

IDOT certifies that it and any subrecipient or contractor that is a provider of public transportation: (a) are currently not furloughing any employees; (b) have, to the maximum extent possible, brought back any employees previously furloughed as a direct result of financial challenges caused by the COVID-19 public health emergency; or (c) have rehired, or posted to rehire, any positions of employees who were laid off as a result of financial challenges caused by the COVID-19 public health emergency.

In addition to FTA's Buy America requirements under 49 U.S.C. 5323(j) and 49 CFR Part 661, which require that the steel, iron, and manufactured goods used in an FTA-funded project are produced in the United States, the Build America, Buy America Act (BABA) (Public Law 117-58, div. G 70914(a)) now requires that construction materials used in infrastructure projects are also produced in the United States. IDOT agrees to the terms and conditions in FTAs Master Agreement, Section 15. #### Original Grant:

This grant to the Illinois Department of Transportation (IDOT) will utilize FFY20 Coronavirus Aid, Relief, and Economic Security (CARES) Act funding. IDOT will allocate 100% of it \$57,457,865 of FFY20 CARES Act Section 5311 apportionment for reimbursements of eligible operating expenses to sub-recipients responding to the COVID-19 pandemic, and to meet its Intercity Bus set aside requirement. Projects under this grant include rural sub-recipient operating and ICB operating costs for the performance period of 1/20/2020 through 06/30/2023.

To encourage rural sub-recipients to fully use CARES Act funds for their Congressional intent, IDOT will be allowing operators to bill for COVID-related expenses back to 1/20/2020. The decision to make funds under this grant available solely for operating expenses will further prioritize utilization for COVID-19 related response and hopefully make tracking and reporting more expedient.

The grant is organized by general activities/ALI and split into two projects. Project One covers General Public Transportation Operating Assistance, while Project Two is for Intercity Bus Operating Assistance. Pre-Award Authority is being used for this grant. As outlined by FTA guidance for CARES Act funds, a match is not required; and IDOT does not intend to make sub-awards where CARES Act monies are further leveraged with local match.

\*The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company.

IDOTs Office of Intermodal Project implementation (OIPI) is the governors designated recipient of the Federal Transit Administrations Section 5311 formula funds for public transportation services in rural and small urban areas in Illinois. Historically, grant recipients submit annual applications for funding to the Department, but in the interest of providing funding stability, it is not a competitive process. Instead, the Department funds its approved eligible sub-recipients each year based upon the States available Section 5311 allocation. The same allocation process will be followed for the CARES Act Section 5311 funding. IDOT intends to make separate, multi-year awards for CARES Act funding, in part, to reduce administrative burden.

Projects under this grant amendment include adding rural subrecipient shop equipment, ADP hardware and software, mobile surveillance and security equipment and software, fare collection hardware and software, facility repairs and misc. support equipment. The performance period of 1/20/2020 through 3/30/2029.

#### Activities to be performed:

The activities to be performed include the purchase of shop equipment, ADP hardware and software, mobile surveillance and security equipment and software, fare collection hardware and software, facility repairs, and misc. support equipment.

Through their best efforts, public transportation operators have worked to mitigate risk and respond to the personal and financial fallout of the crisis. CARES Act funding enacted by the federal government on March 27, 2020 will serve as an important lifeline for these operators, especially those serving rural and small urban populations.

The Centers for Disease Control and Prevention continues to urge people to avoid close contact and stay at home as much as possible. Additionally, a sizable portion of those utilizing transportation services funded through 5311 are older adults and other vulnerable individuals.
