Application Executive Summary

Amendment #2:

This application is to request Section 5311 funds apportioned by the Federal Transit Administration to the Bad River Band of Chippewa Indians in the amount of \$425,209. This grant provides \$425,209 of FY 2023 Section 5311 operating assistance to the Bad River Band of Chippewa Indians transit system (Bad River Transit) for the period of January 1, 2024, to December 31, 2024.

This amendment will not change the period of performance end date for this grant.

AMENDMENT #1:

This amendment adds \$746,847 in Tribal Transit Formula Funds (\$326,246 in LAPSING FY21 Tribal Transit Formula funds and \$420,601 in FY22 Tribal Transit Formula funds) for the purchase of one van, one bus, and bus related equipment for Bad River Transit, as well as operating assistance.

ORIGINAL:

Bad River Transit will use \$370,993 of FY20 5311 Tribal Transit formula funds for the purchase of 4 vehicles, radio communication system, bus security camera system, and diagnostic and other maintenance equipment. In executing this grant, Bad River Band of Lake Superior Chippewa agrees to abide by Section 3011 of the FAST Act (49 U.S.C. 5323(j)(2)(C) regarding the phased increase in domestic content under the Buy America statute for rolling stock. As the Grant Agreement includes an FTA-funded transit vehicle purchase, Bad River Band of Lake Superior Chippewa agrees to comply with the related requirements set forth in 49 CFR 26.49(a). Specifically, the recipient must ensure as a condition of being authorized to bid or propose on FTA-assisted transit vehicle procurements, that each transit vehicle manufacturer certified that it complied with DOT requirements for submitting a DBE program and goal to FTA prior to bidding. The recipient is also required to submit the name of the successful bidder and the total dollar value of the contract within 30 days of making a FTA- assisted transit vehicle award using the required FTA reporting tool. Bad River Band of Lake Superior Chippewa understands that failure to comply with these requirements may result in formal enforcement action or appropriate sanction as determined by FTA,

including reimbursement of FTA funds used for the vehicle procurement.
