This project consists of two activities:

Project Benefits

Our goal is to serve 50-100 regular and diverse riders in the first year of this program. We will use a scaleable and iterative method to launch a transit program that allows the community to participate in our planning activities and shape our demand and routing process. We will prioritize adding more capacity to manage and plan this program, which is a significant investment in learning by doing. We recognize that many Tribal administration departments and their staff have to juggle multiple programs and resources as their "second jobs", which can lead to incomplete, delayed or ineffective implementations and unclear or unattainable outcomes. By supporting the internal capacity to dedicate a resource that is solely responsible for creating this transit program, we will also benefit other ongoing transportation department projects and federally funded activities by addressing this community need without overloading staff and programs, and potentially neglecting other important work.

Location Description

The Karuk reservation is not a single contiguous area of land, but rather a collection of small parcels scattered along the Klamath River in northern California. The Karuk Tribe is one of the largest tribes in California, with 3,751 enrolled tribal members and about 5,000 registered descendants. The tribe has three main population centers: Orleans (Panmniik), Happy Camp (Athithfvuunupma), and Yreka (Kahtishraam), located in Humboldt and Siskiyou counties. The operations of a tribal transit program within this region is essential due to the remote and distributed and rural nature of population centers, critical services like medical care and food supplies, and tribal housing. This project aims to further develop the operating capacity of the Tribal Transportation department to meet the need for a centrally managed and dispatched on-demand public transit/rideshare option for elders, and vulnerable members of our community.
