#### **Application Executive Summary**

D2023-TRTR-015 \$120,000 Gap Funds for 2 replacement buses LAPSING FUNDS

The Jicarilla Apache Nation is seeking additional gap funding for a capital project to purchase two cutaway style transit buses to operate on the North Central Regional Transit District (NCRTD) route 170 Jicarilla serving the Jicarilla Apache Nation, Chama, and Farmington. Due to inflation-related cost increases, the amount of funding awarded for the FY2021 TTP, contained in grant NM-2024-047, is no longer sufficient to cover the cost of the vehicles. Neither the Jicarilla Apache Nation nor the NCRTD have funds available to pay the difference and the project cannot advance without the additional funding being requested from FTA.

The two new buses will replace two NCRTD buses that will exceed their useful life before the new buses are delivered.

The project is necessary to maintain the state of good repair of transit assets, accommodate the physical characteristics of the route, meet the high demand for transit in the area, improve passenger and operator comfort, advance environmental sustainability, make up for limited availability of transit funding, and promote coordination between local government agencies. The project will benefit current passengers, Jicarilla Apache Nations roughly 3,356 residents, and people working in and visiting the area. It is supported by Jicarilla Apache Nation tribal members and government, NCRTD, and demographic and survey data.

When Tribal Transit Program (TTP) funding is awarded, NCRTD will complete the project on behalf of the Jicarilla Apache Nation and continue to provide transit service on the route, and the Jicarilla Apache Nation will sub-allocate the funding to NCRTD. NCRTD has the proven technical, legal and financial capacity to complete the project in a cost-efficient, time-efficient, high-quality manner.

### **Award Description**

#### **Purpose**

The Jicarilla Apache Nation is seeking gap funding from the Federal Transit Administration through the FFY2022 Tribal Transit Program to replace two buses that will exceed their minimum useful life in FFY 2022

The Jicarilla Apache Nation's TTP requested project was funded in FFY 2021, however, due to rapidly increasing costs, it is currently not possible for the project to move forward without additional TTP funding. The Jicarilla Apache Nation's FFY 2022 funding request is inclusive of the additional inflationary costs associated with the procurement of the previously approved two cutaway buses; each one outfitted with necessary transit equipment (CAD/AVL and ITS hardware, a surveillance camera system, a wheelchair lift, head signs, bike racks) and enhanced passenger amenities (a lavatory, more comfortable seats, and USB charging ports). Neither NCRTD or Jicarilla Apache Nation have the financial capacity to cover the incremental costs associated with rapidly rising inflation.

#### Activities to be performed:

Bus procurement - replace two buses.

#### **Expected outcomes:**

The project is necessary to maintain the state of good repair of transit assets, accommodate the physical characteristics of the route, meet the high demand for transit in the area, improve passenger and operator comfort, advance environmental sustainability, make up for limited availability of transit funding, and promote coordination between local government agencies.

#### Intended beneficiaries:

The project will benefit current passengers, Jicarilla Apache Nations roughly 3,356 residents, and people working in and visiting the area. It is supported by Jicarilla Apache Nation tribal members and government, NCRTD, and demographic and survey data.

The quantity of buses is documented in grant NM-2024-047 which contains the majority of the funding for this project.
