The Yavapai-Apache Nation will use 2025 Formula Funds to continue to improve Public Transit. The Yavapai-Apache Nation is completing. Funds from this application will be used to continue the operation of the Yavapai-Apache Transit system for salaries, benefits, maintenance, fuel, supplies and staff travel/training. Funds will be used for employee compensation, and continued safety training as available for all operators and support staff, as required. Remaining funds will be used to assist in covering fuel costs, operational supplies and vehicle maintenance and travel and training. The grant applies for \$295,148 in section 5311 funds for the Yavapai-Apache Nation to support costs such as driver salaries & benefits, vehicle maintenance, operating supplies and travel/training

Activities to be performed:

Activities to be performed will include review of current employee status and adjust salary and benefits as required while adding operators to cover the expanded services. Additional activities will be the additional scheduling of transit vehicles with the expanded routes. Scheduling vehicles for routine maintenance and safety inspections is another activity to be performed. Scheduling of trainings for employees safety and operation trainings will also be performed.

Outcomes expected from this application funding will be to improve Yavapai-Apache Transit by retaining and adding qualified employees,, ensure operators are properly trained, vehicles are safe to operate over the expanded routes
