The software will allow Tribal employees to receive transportation requests for service, dispatch buses, manage driver schedules, provide riders information in real-time, and produce data necessary to assess the transit system, and track ridership needs. The software is critical to ensuring efficient system operations and data collection essential to maintaining the transit system and implementing continual quality assessment/improvement. The NewGen System includes five user licenses. In addition to the software, tablet integration, initial setup, and configuration costs are included as a one-time fee.

The software has a useful life of 3 years. Any equipment exceeding \$10,000 per unit and with a useful life greater than 1 year, and any supplies with an aggregate value greater than \$10,000, will be reported as project property at closeout of this award.
