Application Executive Summary

Amendment #2: This application is to request \$15,408,052 in FFY2025 Section 5311 funds apportioned to the State of Iowa (UZA Code 190000).

Utilizing FFY2025 funds, the application amount includes \$560,235 to purchase one replacement heavy duty bus that will have a useful life of 12 years or 500,000 miles. \$341,360 to purchase two replacement light duty buses that will each have a useful life of 5 years or 150,000 miles. \$13,804,123 for public transit system operating assistance such as driver salaries, fuel, items having a useful life of less than one-year, preventive maintenance to continue transit operations. \$302,334 for Rural Transit Assistance Program (RTAP) activities such as transit training fellowships. \$400,000 for Regional Planning Affiliation (RPA) transportation planning activities such as Passenger Transportation Development Planning (PTDP-Coordinated Human Service Planning) and general transit/transportation planning.
