This application utilizes Tribal Transit Formula funds to cover the remaining costs of full engineering and design of the Rochester Street garage as well as professional services. The remaining funds will be used for operating assistance to cover eligible expenses for FY2026 (operating year 10/1/2025 - 9/30/2026).

The total engineering and design and construction administration cost needed for the Rochester Street Bus Garage project is \$300,000 and \$208,609 is for operating assistance.

The Seneca Nation Seneca Transit System (STS) plans to construct a new bus storage facility on the Allegany Territory to enable public transportation improvements for STS and regional partners. The remaining funds will be allocated to operating assistance to cover eligible expenses such as fuel, driver salaries and third party operator services for FY2026.

Activities to be performed:

The funding will be used for architecture, engineering and design services for a new building for the Rochester Street bus garage located on the Allegany Territory. These activities include the completion of design schematics and construction plans, as well as professional services.

The remaining funding will be used to cover eligible operating expenses for FY2026 (operating year 10/1/25 - 9/30/26)
