Application Executive Summary

This grant provides a total of \$45,515,266 in federal funding matched with \$36,264,841 in State funding, and \$370,333 of local funding to purchase vehicles, equipment and rehabilitation and construction on facilities, provide administrative support and technical assistance, and operate public transit and intercity bus service in the rural areas of the State of Michigan. Operating projects are funded at 50% Federal Share, RTAP and Program Admin projects are funded at 100% Federal Share. Capital projects are funded at 80% Federal share unless otherwise noted in the Budget Activity Line Item.

The grant utilizes FY24 and FY25 Section 5311 Rural Formula funds apportioned to the Michigan DOT in the amount of \$38,545,023. The \$34,464,893 state match will be provided from the Comprehensive Transportation Fund (CTF), and \$330,000 will be local match provided by the Intercity Bus Program Provider. The breakdown is as follows:

State's Comprehensive Transportation Funds (CTF) in the

amount of \$1,057,386 will be used to match these projects.

This grant will also provide FY2025 Section 5311 Flexible funds in the amount of \$2,970,243 will be used by the Michigan Department of Transportation to purchase vehicles, equipment and rehabilitation and construction on facilities. Projects funded for MDOT's FY 2025 flex capital program.
