Application Executive Summary

This is the State of Mississippi statewide application to request funding apportioned to the State for the Section 5311 Rural Area Program FFY 2025 in the amount of \$20,369,607: Appalachian Development PT Assistance Program FFY 2025 in the amount of \$325,675. This application includes a total for \$21,041, 707 in federal funds. This application also includes Section 5311 (b) (3) RTAP funds of \$346,425 FFY 2025.

Based on the allocations, the grant application will comprise of four (4) projects:

- 1. Rural Area allocation \$18,332,646
- 2. Appalachian allocation \$325,675

- 3. RTAP allocation \$346,425
