This application is to request FY25 Section 5311 Tribal Transit Program Formula funds apportioned to the Cheyenne River Sioux Tribe (CRST) for the amount of \$654,931 (full apportionment), representing 100% federal share of the total eligible amount. The funds will be used to pay monthly invoices to River Cities Public Transit who the CRST currently have a contract with for operating assistance and preventative maintenance for the Tribal Transit Program.

CRST is requesting pre-award authority in the amount of \$462,048 for reimbursing contract expenses paid by the Tribe starting 2/1/2025. Actual pre-award expenditures and obligations will be reported in the initial Federal Financial Report.
