## Award Description

#### Purpose

Aniak has no transit services. The roads are gravel or dirt and there are no sidewalks. There are only a

few lights. Winter days are dark and short with no direct sun and temperatures can reach -51 F. The roads are dusty in the summer, snowy and icy from September to April and muddy in May and August. Bears, moose, fox, wolverine, wolves, and other animals are common. The community needs this service and there are also all the people who come through Aniak for the airport, the clinic, and the grocery store who have no way to get to places but to walk. The project will establish a transit program providing regularly scheduled service to and from the airport, clinic, grocery store, tribal offices, school, and riverboat landing. The community and tribal government support this project and have identified it as a clear and compelling community need.

**Activities to be performed:**

Reliable, scheduled transportation has been a need for a very long time. The project will have an ADA compliant, all-wheel drive, high clearance van with studded snow tires to provide transit service in Aniak including to the school, airport, and boat landing. No facilities are required. There are no existing transit programs.

**Expected outcomes:**

The project will benefit the community by allowing people to go to the grocery store, school, library, offices, clinic, airport, post office, and boat landing without walking in adverse weather, on unlit roads in the dark, in the cold, in storms without fear of encountering moose, bears, foxes, wolverines, wolves, or stray dogs. The transit service will benefit local people and people who come to Aniak for services or connections. The transit service will benefit elders, people with disabilities and mobility issues, people who cannot or should not walk, children, ill people, pregnant mothers, and people with luggage / groceries. In Alaska it can be exceptionally isolating to be forced to be home, to not be able to walk to the school or store and this takes a toll on mental health in the state with the highest suicide rate in the country.

**Intended beneficiaries:**

Aniak is a subregional hub community meaning that many villages fly into Aniak to access the flight to Bethel where the regional hospital is or to Anchorage for a wide stream of services including all health care that is not triage or well care. Additionally, Aniak has a sub-regional clinic that serves all of the surrounding villages. Some of the villages surrounding Aniak have no grocery stores. People fly to Aniak every day for healthcare, dental care, access to flights and other services, for the Alaska State Trooper outpost, and for groceries. People travel to Aniak by air and on the river and then must walk to the clinic, other airlines, or the grocery store from the riverbank or airport. Many people traveling for healthcare have limited mobility or are hurt or unable to walk or the winter weather and dark winter nights is not a healthy option, especially for elders and young children. The project will establish a transit program providing regularly scheduled service to and from the airport, clinic, grocery store, tribal offices, school, and riverboat landing. The community and tribal government support this project and have identified it as a clear and compelling community need. The route has been mapped. The vehicle will be an all-wheel drive high clearance ADA-equipped van. The van will be stored and maintained by the tribe. The transit program will provide regularly scheduled service through the community to the stores, airport, clinic, boat landing, school, library, tribal offices, and youth program. It will assist elders in getting to the school for elder lunches and children attending the tribes youth program as well as visitors trying to access services in Aniak.
