Application Executive Summary

The Lac du Flambeau Tribe will use \$300,000 in FY15 5311 Tribal Transit Program Discretionary grant funds to support existing service and a new expansion of bus routes for education, employment and health care access, connecting the Lac du Flambeau community to the neighboring communities of Woodruff, Minocqua, Hazelhurst, Arbor Vitae and Rhinelander, WI. The Tribe will provide "tripper services", that will be open to the public, and will operate with regular route schedules and fares.

The Tribe will use \$300,000 in federal grant funds with a 10% tribal match of \$33,334 from BIA Road funds to cover the cost of this expansion, and for capital expenses for two 2018 Ford E350 Cutaway Diamond Coach Buses, with 12 Ambulatory and 1 Wheelchair seating capacity, for each vehicle. The buses will both have a useful life of at least 4 years and will each be used in excess of 100,000 miles. The current fleet of five vehicles utilized to provide these services averages 246,817 miles of service, with the highest vehicle at 387,396 miles. We anticipate that we will have one spare transit vehicle, not in revenue service, after the two bus purchases.

The Tribe is also in the process of completing a facility expansion project at the current transit operations hub, located at the LdF Tribal Roads Department, with separate grant funds. This construction project will be completed by September 30, 2018, and will provide the required infrastructure for accommodating the increase in fleet size. We anticipate that our contract award date for the new buses will be July 31, 2018.

Project Description

The Lac du Flambeau (LdF) Tribe will utilize \$300,000 in FY15 5311 Tribal Transit Program Discretionary grant funds to support the expansion of routes for education, employment and health care access. The funds will help with the cost of this expansion and for capital expenses for two buses. The Tribe will provide "tripper services", that will be open to the public, and will operate with regular route schedules and fares. The Tribe will use federal grant funds, with a tribal match from BIA Road funds, to cover the cost of this expansion. These funds will also be used for capital expenses for two 2018 Ford E350 Cutaway Diamond Coach Buses, with 12 Ambulatory and 1 Wheelchair seating capacity, for each vehicle. The buses will both have a useful life of at least 4 years, and will each be used in excess of 100,000 miles of service, with the highest vehicle at 387,396 miles. The Tribe will be operating a six bus transit system, with one spare transit vehicle, not in revenue service, after the two bus purchase, on the Lac du Flambeau Reservation and in the neighboring communities of Woodruff, Minocqua, Hazelhurst, Arbor Vitae and Rhinelander. The buses will operate six days a week, with a passenger schedule that ranges from 12-18 hours each day, depending on the route of service.

This project provides \$125,016 in FY15 5311 capital funds to support the bus procurement, \$97,787 in operating assistance to support the two expansion routes through 9/30/19, as well as \$77,197 to support existing route service capacity through 9/30/19.

Project Benefits

This service would continue to provide demand responses to the Ojibwe Market, and other retail centers in the community, the Peter Christensen Health Center and Marshfield Clinic-Minocqua Center, the Family Resource Center (mental health and alcohol and other drug abuse outpatient

counseling services), the Lac du Flambeau Tribal offices and other community destinations, serving the community's congregate housing sites.

Additional Information

The Lac du Flambeau Transit Development Plan (under Option III), developed in 2012 by LSC Transportation Consultants, the regional connection is advantageous to the Lac du Flambeau community by "providing a direct connection from LdF to Rhinelander. It would increase opportunities for Lac du Flambeau residents to access regional trips for employment, education, shopping, and medical trips to and from Rhinelander."

The expanded fixed-route service would be available to the public, and will operate with regular route schedules and fares, providing expanded access to medical, education, and employment to and from Rhinelander, Wisconsin and neighboring communities.

In executing this grant, Lac Du Flambeau Tribe agrees to abide by Section 3011 of the FAST Act (49 U.S.C. 5323(j)(2)(C) regarding the phased increase in domestic content under the Buy America statute for rolling stock. As this Grant Agreement includes an FTA-funded transit vehicle purchase, Lac Du Flambeau Tribe agrees to comply with the related requirements set forth in 49 CFR ? 26.49(a).
