The federal awarded amount for this vehicle is \$46,761. The state awarded amount is \$11,690 for a project total of \$58,451. This vehicle replacement is expected to be purchased on the MDOT contract for full-size vans. The MDOT contract is expected to be awarded sometime in Fall 2018.

The useful life of the old/new vehicles is 7 years.

The van with lift replacement is due to a vehicle that has met its useful life as of September 2017. The new vehicle will feature transit style doors, which is what several customers have requested in our service area. The customers find them easier to enter/exit.
