#### **Application Executive Summary**

The California Department of Transportation (Caltrans) is a Designated Recipient. This application is for federal assistance from Congestion Mitigation and Air Quality (CMAQ) funds (Federal Fiscal Year 2017 appropriation), which have been transferred from the Federal Highway Administration (FHWA) to the Federal Transit Administration (FTA) for administration under Section 5311. The grant application requests \$282,000 for two (2) projects.

The projects to be funded from the award are capital bus replacements for Caltrans subrecipients Mountain Area Regional Transit and City of Dinuba. A Program of Projects (POP), Project Descriptions per programming documents, and Project Details are entered as part of Activity Line Items (ALIs) and/or uploaded documents associated to this application in the TrAMS system.

Both projects meet the following CMAQ eligibility requirements.

- 1) All projects are transportation projects.
- 2) All projects generate an emissions reductions.
- 3) All projects are located in or benefit a non-attainment or maintenance area.

Grant funding is \$282,000 from Federal Share, of which \$17,025 is attributable to Transportation Development (Toll) Credits, and \$18,000 from Local Share. Total Project Costs equal \$300,000. Because California has a signed agreement with FHWA for sliding scale rates pursuant to 23 USC 120(b)(2), CMAQ funds flexed to 5311 have a minimum required Local Share of 11.47% and a maximum Federal Share of 88.53%. Due to the use of Toll Credits in lieu of Local Share in this application, the effective Local Share for this application is 6.00% and the effective Federal Share is 94.00%.
