This application is to the Federal Transit Administration from the Red Cliff Band of Lake Superior Chippewa Indians for protein that will utilize FY16 Discretionary and FY17 Apportionment funding received through the Section 5311 (c) Discretionary further for planning and 5311 (j) Public Transportation on Indian Reservations program funds for Operating Assistance.

#### **Project Description**

Like many Tribal Governments, the Red Cliff Band has several programs that include some type of public transportation element within them. These public transportation elements within those Red Cliff programs are disconnected from one and often duplicate services. A comprehensive study of these transportation elements would identify the inefficiencies of the services and begin to organize and unify the administration and delivery of services.

#### **Project Benefits**

The benefits of a well laid out transportation plan would have lasting effects on the Red Cliff Band and surrounding communities. The plan would address the disconnected delivery of service, identify areas of improvement and potential sharesources, such as drivers and facilities and ultimately eliminate duplicated services.

The public would benefit from their participation in the process by helping to improve response to their transportation needs increasing the capacity to transport more individuals more economically through the implementation of the plan. This equaincreased access to jobs and education, health care and social events and would provide a dependable means of transportation to a population dependent on transit services for their quality of life.

### **Additional Information**

As described throughout this application there is a need for increased capacity and a long term plan for continued operation. The transit planning process will identify the areas Miskwaabekong Transit can partner with other Red Cliff Tribal programs streamline operations. This process will also help identify the areas that need improvement in the delivery of all public transportation within Red Cliff and the surrounding communities, where and how service and capacity can be expanded an

will identify the resources needed to fulfill the goals of improved transportation services.

The Red Cliff Band is committed to public transportation long term and has committed resources through Tribal Council Resolution 4-19-16B in support of the development and construction of a transportation facility for Miskwaabekong Transit other transportation related programs of the Tribe. In addition the Red Cliff Tribe by resolution 11-17-15D approved the FY to FY2019 Tribal Transportation Improvement Program (TTIP) authorizing \$70,000 annually for transit operations from the Tribal Transportation Program annual Tribal shares.

At a very minimum, implementation of the plan through a well coordinate planning process, will begin by combining the fragmented public transportation elements that operate under the different Red Cliff Tribal programs under one public transportation program, eliminating the need for several managers and allowing funding to flow down for increased service the users of public transportation.

Implementation of the plan will help meet the challenges faced in expansion and continued operations by supporting and strengthen future funding application for capital projects identify through the planning process or carry out options propose stakeholders that address peak demand hours.

This application is to the Federal Transit Administration from the Red Cliff Band of Lake Superior Chippewa Indians for projects that will utilize FY16 Discretionary and FY17 Apportionment funding received through the Section 5311 (c) Discretionary funds for planning and 5311 (j) Public Transportation on Indian Reservations program funds for Operating Assistance.
