Application Executive Summary

This grant provides \$7,262,958 of FY2019 Section 5311 funding (full apportionment) for operating assistance, project administration, state administration (10% of total apportionment), intercity bus (15% of total apportionment) and preventive maintenance for eligible transit providers in Wyoming as well as \$105,765 of FY2019 Section 5311 RTAP funding. Local match totaling \$3,886,057 will be provided from multiple local sources which are detailed in awarded funding applications on file at WYDOT. WYDOT is using the sliding scale match ratio (56.56% Federal and 43.44% Local) for operating funds per an approved agreement with the FHWA Division Office. Project Administration and Preventive Maintenance projects are 80% Federal and 20% Local. State admin and RTAP are at 100% federal.
