The Massachusetts Department of Transportation (MassDOT) is requesting FFY'19 Section 5311 Non-Urbanized Area Formula Grant funding in the amount of \$8,077,751 (\$4,311,052 Federal/\$3,766,699 Local) for Operating Assistance, Intercity Bus, RTAP and state administration. The grant also provides operating assistance to support Intercity Bus Service in the Commonwealth of Massachusetts. Funds of \$627,783 (50%) will be used to subsidize operating costs for Intercity Bus routes. The Intercity Bus operators and routes will be selected from a competitive application process which will begin mid-July, 2019. The notice of solicitation will be posted by MassDOT on its website in July, 2019. Awards will be made in September, 2019. MassDOT will issue one-year contracts with the intercity bus operators, with an option to renew for additional terms pending annual performance and compliance reviews. This funding is for year 2 of the award program. The Intercity Bus carriers selected will be responsible for proving the local match. Once the awards are made, a Budget Revision will be created to move the 15% Intercity funds to an ALI for each sub-recipient.

RTAP:

Funds of \$125,831 of the statewide apportionment is requested to continue MassDOT's successful Massachusetts Rural Transit Assistance Program (MArtap). Through its MArtap program, MassDOT offers several courses each month such as: Defensive Driving, Accessible Lift Use and Passenger Securement, Disability Awareness, and Drug & Alcohol Awareness Safety Sensitivity training (on-line). The MArtap Training Programs are exemplary in that it provides `no cost` training to hundreds of drivers a year. In addition, the RTAP program offers technical assistance to include scholarships. ADMINISTRATION:

MassDOT hereby requests ten (10%) percent of the FFY'19 apportionment (\$418,522) to be used for State administration and technical assistance. A Local Match is not required.
