The California Department of Transportation (Caltrans) is a Designated Recipient. This application is for federal assistance from Congestion Mitigation and Air Quality (CMAQ) funds (Federal Fiscal Year 2019 appropriation), which have been transferred from the Federal Highway Administration (FHWA) to the Federal Transit Administration (FTA) for administration under Section 5311. The grant application requests \$320,000 for one (1) project.

The project to be funded from the award is transit operating assistance for Caltrans subrecipient Kern Regional Transit. A Program of Projects (POP), Project Description per programming documents, and Project Details are entered as part of Activity Line Items (ALIs) and/or uploaded documents associated to this application in the TrAMS system.

Comment	The attached document, FHWA / CMAQ Federal Share Documentation, details the allowable Federal Share for transfers of funding between FHWA and FTA. Applicable sections are highlighted with the attachment. 23 U.S.C. 104(f) - Transferred funds remain subject to the Federal Share that applied to the category from which the funding was derived. See chart on page 2. 23 U.S.C. 120(a)-(b) - Sliding Scale - of 90-95% for a project on the Interstate System and 80-95% for any other project or activity. California is a Sliding Scale State.

Comment Type FTA Post Review Comments for Grantee Date 4/4/2019 This application is well-written; however, there are two issues, one minor, one major: 1) Minor - I changed the NEPA CE finding to C4 which applies to operations. 2) Major - The maximum Sliding Scale Rate for Transit Operating Grants available to California is 55.33% (see p. III-18 of FTA C 9040.1G). With a FHWA transfer of \$280,000, this means the Total Project Cost could be \$506,054. Conversely, if the Total Project Cost is \$320,000 as the KernCOG FTIP appears to indicate, Caltrans can only apply for \$177,056 of the \$280,000 transferred.

Comment	Per my emails on 4/16 and 5/2, FTA Region 9 has determined that Caltrans Recipient Documents do not contain authority to apply for and receive FTA 5311 grant funds. For a new authorization signed by the Governor, it would be helpful to generically indicate that the California Department of Transportation (Caltrans) is authorized to apply for and receive funding made available under 49 U.S.C. Chapter 53 (FTA programs), which may also include funds transferred from Title 23 U.S.C. (FHWA programs), on behalf of

the State of California as the Designated Recipient for the applicable federal transit programs.
