The Uniform National Threshold Entered Employment Rate (UNTEER) was 58.5 percent in 2018. Nine states and territories failed to meet 90 percent of this threshold (equating to 52.7 percent). The UNTEER was calculated from the 6/30/2018 WIOA data as certified in the Workforce Integrated Performance System. UNTEER follows an entered employment calculation, which differs from current Workforce Innovation and Opportunity Act calculations. Specifically, the figures below represent the percentage of exiters who were unemployed or received notice of termination/lay-off at time of participation who were then employed within the first quarter after exiter.
